1.	Value-Added Textile Manufacturers / Non Active Export Industries/Temporary Closed Units	Rs. 15,000/-
2.	Value-Added Textile Manufacturers & Exporter/ Indirect Exporter (Export up to 01 Million USD)	Rs. 30,000/-
3.	Value-Added Textile Manufacturers & Exporter (Export above 01 Million up to 40 Million USD)	Rs. 60,000/-
4.	Value-Added Textile Manufacturers & Exporter (Export above 40 Million USD)	Rs. 100,000/-
5.	For New Membership - Admission Fee (One Time) (Along with Annual Membership Fee in any of above categories)	Rs. 25,000/-
