Notice is hereby given that the proposed rates together with objections and suggestions with respect thereto will be received by the Secretary Minimum Wages Board Sindh, Karachi, within a period of thirty days from the date of publication of this notification in the official Gazette and shall be taken into consideration by the said Board under Rule 14(2) of Rules ibid. Any objection / suggestion received after the expiry of said period of 30 days will not be considered.

Draft recommendations regarding fixation of minimum rates of wages of all categories of workers (skilled / semi skilled & highly skilled) in 41 different industries in the province of Sindh

Minimum Wages Board has decided to increase the minimum rates of wages by 28.33% (20% according to increase in 2014 & 8.33% in 2015) w.e.from 1st July, 2015 of all categories of workers (skilled, semi skilled and highly skilled) of 41 different industries as specified in Labour Department, Government of Sindh's Notifications No.L-II-13-4/78 dated 13th March, 2014.
