

We request our brotherly country for award of this status to Pakistan making the regular import duty, zero from Pakistan

The safeguard import duties imposed to protect the respective sector in Turkey like textiles will remain in place for Pakistan even after award of this status

Turkey's total imports from Pakistan (excluding \$163 million of raw cotton) are only US\$243 million i.e. only 0.1% of US\$251,650 million totals import of Turkey from the world

Therefore award of the above status to Pakistan will not be a big burden to Turkey but indeed be a boost to Pak-Turkish trade and deservedly give the same status to Pakistan as given to other GSP Plus Countries

This will be in line with the time tested brotherly relationship of both countries and help Pakistan overcome this difficult phase in its war against terror and boost meaningful employment in Pakistan
