DLTL 2015-16 - REVISION IN CALCULATION METHOD

Reference is made to EPD Circular Letter No. 15 of 2015 regarding DLTL 2015-16 scheme of Ministry of Textile Industry and our Letter No. FEOD/7846/DLTL-2016 dated 19-04-2016.

The instructions regarding the revision in calculation method for DLTL claims as provided in our above mentioned letter are also applicable for the DLTL 2015-16 claims. Accordingly, the rates of exchange to be used for claims of DLTL 2015-16 are listed in the attachment.

You are advised to workout revised claims and submit certificates / undertakings by the authorized dealer, claimants and associations for the revised amounts of claims.

It may be noted that there is no need for updating the exchange rates and corresponding PKR values in the data uploaded by claimants at the Ministry of Textile Industry website RDACell.com. However, all other data on the website must be complete as this data is used by us for calculating the DLTL by applying the exchange rates at our end. Any amendments in data required as a result of discrepancies pointed out by us must also be done on the website besides responding to the discrepancies within the timeline given in Ministry of Textile Notification.

DLTL SCHEMES - REVISION IN CALCULATION METHOD

Reference is made to EPD Circular Letter No. 9 of 2014 and 11 of 2015 regarding DLTL 2014-15 (Textile) and DLTL 2015 (Excluding Textile) respectively and our Letter No. FEOD/28769/DLTL-2014 dated 16-12-2014. In this connection, it is notified that the concerned Ministries have decided to revise instructions regarding the exchange rates to be applied for conversion of various foreign currencies and for calculation of year to year percentage increase and payable DLTL. Under the revised instructions, yearly average of SBP DMMD WAR of the base year would be used for conversion of foreign currencies of both years (base and performance). All amounts will be converted to USD and increase will be calculated in USD. The DLTL at applicable rates on category wise enhanced exports (beyond 10%) will be calculated in PKR using the yearly average of SBP DMMD WAR of the performance year. The rates to be used for this purpose are listed in the attachment.

As a result of the revised instructions, amounts of claims will change. You are advised to submit certificates / undertakings by the authorized dealer, claimants and associations for the revised amounts of claims to enable disbursement of claims upon availability of funds.
