My dear

India and Pakistan are neighboring countries with great potential of mutual trade. India has given Most Favoured Nations (MFN) status to Pakistan whereas Pakistan allows imports from India on the basis of positive list. At present 1938 items are included in the positive list.

 Inspite of the fact that India has given MFN status to Pakistan, Pakistan's exports to India are far less than our imports as indicated by the following data:
