

PUBLIC NOTICE

RE-VALIDATION OF WEBOC USER ID'S ISSUED PRIOR TO AUGUST 26<sup>th</sup> 2012


In order to facilitate genuine trade, it is intimated that all the User ID's issued before issuance of Standard Operating Procedure i.e. August 26, 2012, are required to be re-validated and updated immediately. This will require the User-ID holders to make personal appearance and be photographed by designated Deputy/Assistant Collectors of Customs in MCC PaCCS Karachi or in the relevant Customs Collectorate of jurisdiction. The following documents are required to be produced at this time. (for details please consult the SOP at <http://www.weboc.gov.pk>)

- a. Original Taxpayer Registration Certificate (previously known as NTN (or FTN), with endorsement "Registered for Sales Tax w.e.f.")
  - b. Original Sales Tax Registration Certificate with STRN *unless the Taxpayer Registration Certificate (as above) has the Sales Tax endorsement.*
  - c. Original License (in case of Customs/Shipping Agent etc.)
  - d. Original Computerized National Identity Card or individual/partners of firm/directors of a company/ or of authorized persons of a government department/embassy or an international organization etc. , as the case may be.
  - e. In case of Government, Semi-Government, Embassies, AOP, Companies etc. Original letter of authority and nomination in favour of authorized person, signed by the Principal Officer of the organization, company/AOP etc.
  - f. Original Agreement/Articles of AOP; Original SECP incorporation certificate; Original Trust Deed in case of a Trust as applicable.
  - g. Authority letter in favour of authorized person, issued by head of government department, embassy or International Organization etc., as the case may be.
2. All User-ID holders are requested to ensure that their email address given in their NTN data is their own and same as given in their user-ID application.
3. All the User ID's issued before August 26<sup>th</sup>, 2012, if not re-validated are to be blocked. User-ID holders are advised not to wait till their clearances become due, and seek this update at first convenience.
