SUBJECT: DEADLINE FOR SUBMISSION OF EOBI/SSI REIMBURSEMENT CLAIMS

The undersigned is directed to refer to the subject cited above and to say that as per direction of the MINTEX the deadline for submission of EOBI/SSI reimbursement claims for the period October 2009 to September 2011 has already been extended three times. However, the final deadline for submission of claims pertaining to above period is 30th June, 2012. Therefore all units are advised to submit the verified documents for each quarter separately for the above mentioned period to the TCO before expiry of deadline of 30.06.2012.

2. It is further intimated that units may submit the verified documents for each quarter for the period October, 2011 to June 30, 2012 upto 31st August, 2012.

3. In future units may submit the claims within one month for the preceding quarters.
