INSPECTION OF EXPORT CONSIGNMENTS BY ANTI NARCOTICS FORCE FOR DRUG INTERDICTION

All Goods Declarations related to exports are processed by offices and staff of MCC Exports. Drug enforcement related work is performed by Anti Narcotics Force (ANF). Some of the GDs are profiled as risky by ANF and are detained by them for detailed scrutiny by serving detention memos to the terminal operators. Normally, goods are first examined and cleared by Customs and are then detained at last stage for inspection by ANF This practice results in duplication of efforts and damage to cargo as the containers are opened and inspected multiple times, which causes inconvenience to exporters and their clearing agents as well as terminal operators.

- 2. In order to streamline working of drug enforcement related work, it is notified for the information of all concerned that all such export consignments falling under the jurisdiction of MCC Exports, Karachi which are placed on hold by the Anti Narcotics Force shall be subjected to drug check by ANF first. Customs examination and other formalities shall be conducted after drug check by ANF staff. The ANF shall also inform the C stoms staff details of the containers placed on hold for drug check.
- 3 Terminal Operators viz. KICT, PICT, QICT, KPT and others are directed under section 14-A of the Customs Act, 1969, to designate an exclusive area in their respective jurisdictions for all such consignments / containers, which are placed on hold by ANF, and shift all such consignments directly to the designated area after Gate-in for drug check by ANF. In all such cases, if contrabands are detected, further proceedings shall be made by ANF. However, if no contrabands are found by ANF, the terminal operators shall inform concerned Customs staff for completion of Customs formalities.
