**NOTIFICATION**

**NO.SOJI/8-1/2014 (LEAs-Uniform):** WHEREAS, the Commissioner Karachi vide letter No. PS/CKD/837/2014, dated 12<sup>th</sup> July, 2014 has reported that the sale of uniforms of various forces takes place openly, which is a serious threat for the law and order and in certain cases attacks have been carried out using such uniforms. Therefore the Commissioner Karachi has requested to prohibit the following practices u/s 144 Cr.P.C as precautionary and prohibitory measures in public interest:-

- i. Sale of Armed forces / Security Agencies / Para Military /Police Uniform cloth by the mills to general traders except authorized agents of various services carrying authority letter of the concerned Force HQ.
- ii. Stitching /Sale / Display of such uniforms in Bazaars /Markets.

AND WHEREAS, the Government is satisfied that in order to maintain law & order and to curb the use of such uniforms of the law enforcing agencies by unauthorized persons, it is expedient to take necessary measures in the Province of Sindh.

NOW THEREFORE, the Government of Sindh in exercise of the powers conferred under Section 144 (6) of Cr.P.C, hereby impose complete ban on above mentioned practices in the Province of Sindh with immediate effect and for a period of three months.

In pursuance of Section 195 (1) (a) Cr.P.C, the police officers not below the rank of S.I.Os of concerned Police Stations are hereby authorized to register the complaints under Section 188 PPC in writing for the violation of Section 144 Cr.P.C against the violators of this order.
