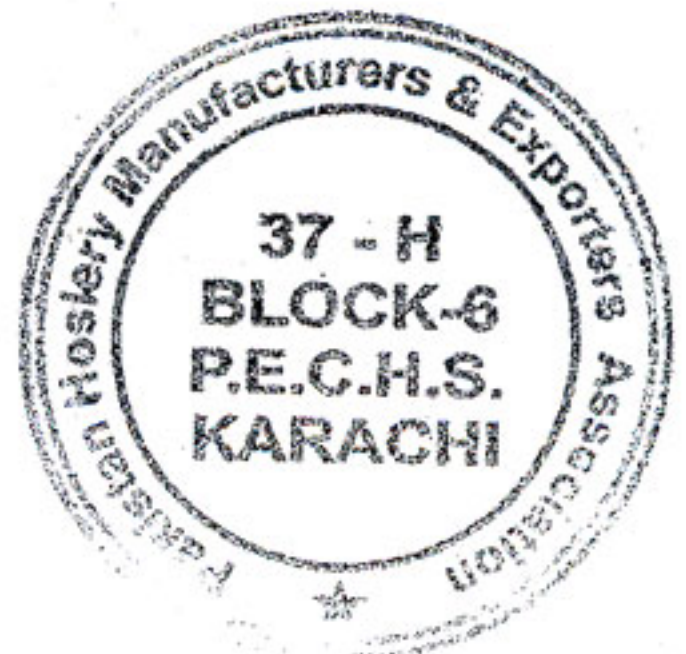

Jawed Bilwani elected chairman PHMEA

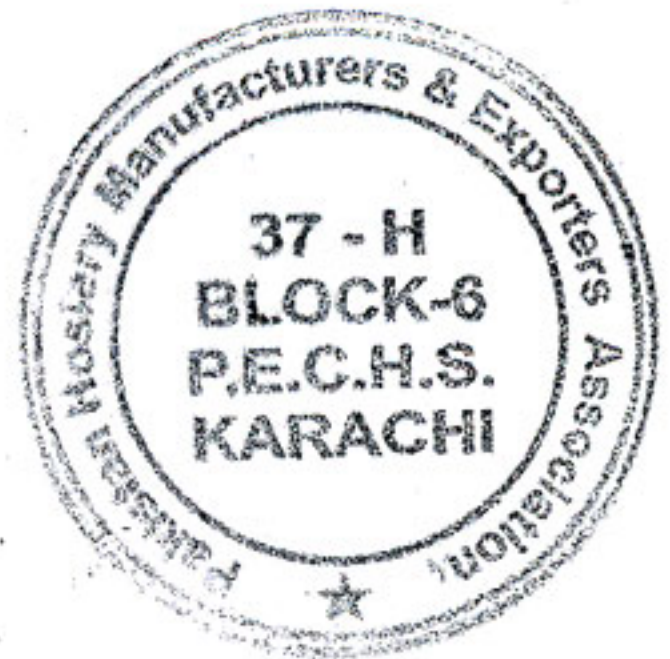

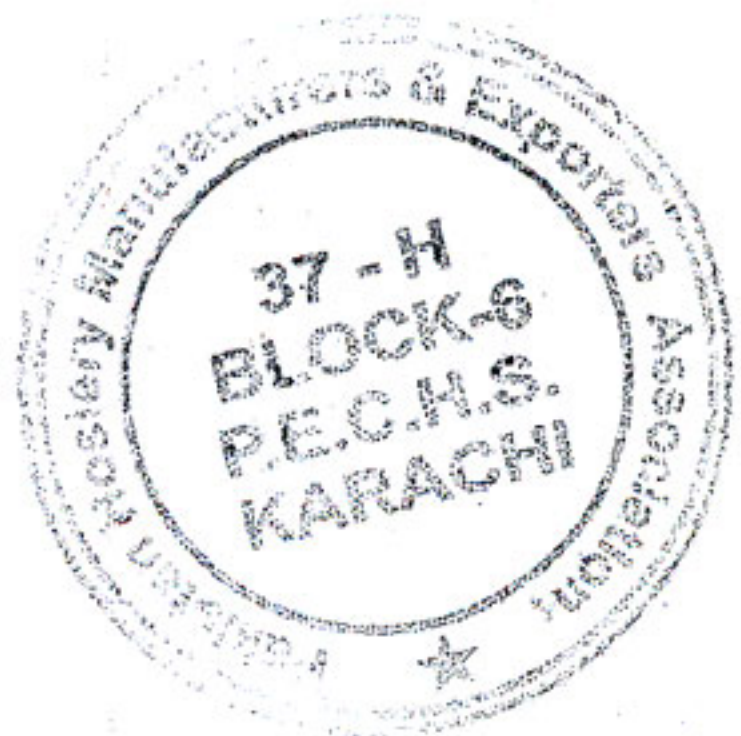
