SUBJECT: REGISTRATION OF THE TEXTILE UNITS WITH TEXTILE MINISTRY

RDA cell has been using NTN, EOBI and SS registration as the prerequisite for the units applying for the registration with the Ministry of Textile Industry. However, initially relaxation was given to the units and non-compliance on following issues was not taken into account:

- a. All addresses i.e. Head Office and Factory, are registered with FBR, EOBI and SS or not.
- b. Nature of business registered with FBR i.e. the unit is textile or not
- c. Whether the unit is active taxpayer or not.
- d. Unit is blacklisted or not

2. To increase the compliance level, we will not be supporting the entities which are incompliant to FBR or any other government rules and regulations such as EOBI etc. So it has been decided by the Ministry that:

- a. Ministry will not register the new applications till they comply with indicators mentioned under para 1.
- b. All previously registered units are required to update their status with FBR, EOBI and SS before 31st December, 2011. Ministry will start the process to check status of previous units those have already been provided with valid permanent certificates and incase of non-compliance will instruct SBP to halt their payments.

3. All the Textile Associations are, therefore, informed that they must check the above requirements before verification of the new registration forms of their members. They are also requested to inform already registered members to enhance their compliance level
