2. As per understanding reached during the Prime Minister's visit to Baku, Azerbaijan from 13-15 October, 2016, the Minister for Commerce will be visiting Azerbaijan on 5-6 December, 2016 in order to enhance trade relations with Azerbaijan.

It is therefore; requested to please constitute a business delegation of at least top ten textile exporters of Pakistan on self finance basis to accompany the Minister for Commerce on his visit to Baku, Azerbaijan from 5 - 6 December, 2016.
