"A quarter of total cases or 470 were settled, resulting into transfer of Rs6.96 billion in sales and customs rebates to exporters," Ahmed said addressing a meeting at the Pakistan Hosiery Manufacturers **Exporters** Association and (PHMA).


Bilwani said presently customs authorities give approval to duty and tax remission scheme for exporters (DTRE), manufacturing bond and Export Processing Zone applications of the exporters, "which take a considerable amount of time and formalities".

"These approvals should be given by the ministry of textiles, which already has all the details of exporters," he added. "If valueadded export sector is facilitated, exports could be doubled in five vears."
